Vendor Cost: \$125 per 12 foot by 12 foot vendor space

Exceptions will not be made regarding the vendor cost under any circumstances.

Vendors will be billed pending acceptance – **do not mail payment with the application
Accepted vendors will know by July 1, 2025 if accepted and must pay upon acceptance.*

Notes:

- Vendors are responsible for bringing a tent, table and chairs for their vendor space
- Vendors are responsible for setting up and packing up their space
- Vendors must be present from setup to tear down
- Vendors may **not** make location requests
- Vendors are responsible for facilitating transactions and charging and reporting applicable sales details and 6% sales tax to the State of Michigan.
- Electrical power and Wi-Fi are **NOT** provided by the Grosse Pointe Chamber of Commerce. Please plan accordingly.

Application deadline: June 13, 2025

Application Requirements:

- With the below application – 3 photos must be submitted to show artist work
- All art must be in good taste and be “family friendly”
- Appropriate vendor categories include paintings, prints, jewelry, glasswork, metalwork, ceramics, sculpture, clothing, etc.
- Products sold by vendors must be original work created or reinvented by artist

Additional Notes:

Due to space limitations, vendor maximums are in place to optimize accommodations. The Grosse Pointe Chamber of Commerce looks to optimize vendor success and reserves the right to accept or deny applicants. Accepted vendors are subject to a nonrefundable \$125 participation fee.

All vendor work must be original and should not bear the name or be affiliated with another person **or** organization.
